Assessment Opportunities

Unit 2 is a 60 GLH unit which is externally assessed.

Students complete a DIN task each lesson, which is a knowledge retrieval activity based on the previous learning. Students self-assess after a class discussion.

Students are also assessed at least twice per half term using exam style case studies and questions. Students are provided with at least one piece of individual feedback and one piece of whole class feedback per half term.

Literacy/Reading opportunities

Within this unit, case studies are used regularly in class and during assessments, which allows for reciprocal reading. In particular, case study scenarios are used in LO1 when discussing potential hazards to individuals in HSC settings.

News articles from responsible sources are used particularly in LOI and LO2 which provides further opportunity for individual and whole class reading.

CEIAG Links

In this unit, students study a variety of career areas in LO3. Students explore the roles and responsibilities, as well as the consequences of not meeting responsibilities in roles within the NHS, local authority, Care home managers, Head Teachers and employees and management roles within charities such as Barnardo's and Age UK.
